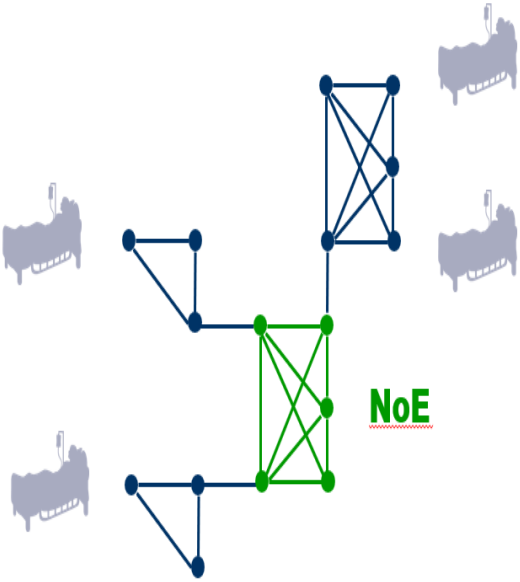
The Joint Action also involves 20 Affiliated Entities.

Context and Objectives

- JANE is one of a series of complementary Joint Actions rooted in the European Beating Cancer Plan.
- Ambition of JANE is to shape seven European Networks of Expertise (NoEs) for cancer care-related issues requiring cross-border cooperation and European-level know-how.
- Unlike European Reference Networks for rare cancers and National Comprehensive Cancer Centres - both directly linked to patients - NoEs will provide services & tools to cancer institutions and networks in Europe.
- Main goals are:
 - lay foundations and prepare groundwork to launch the NoEs;
 - critically evaluate existing models of current and future EU networking aimed at optimizing functioning of new NoEs



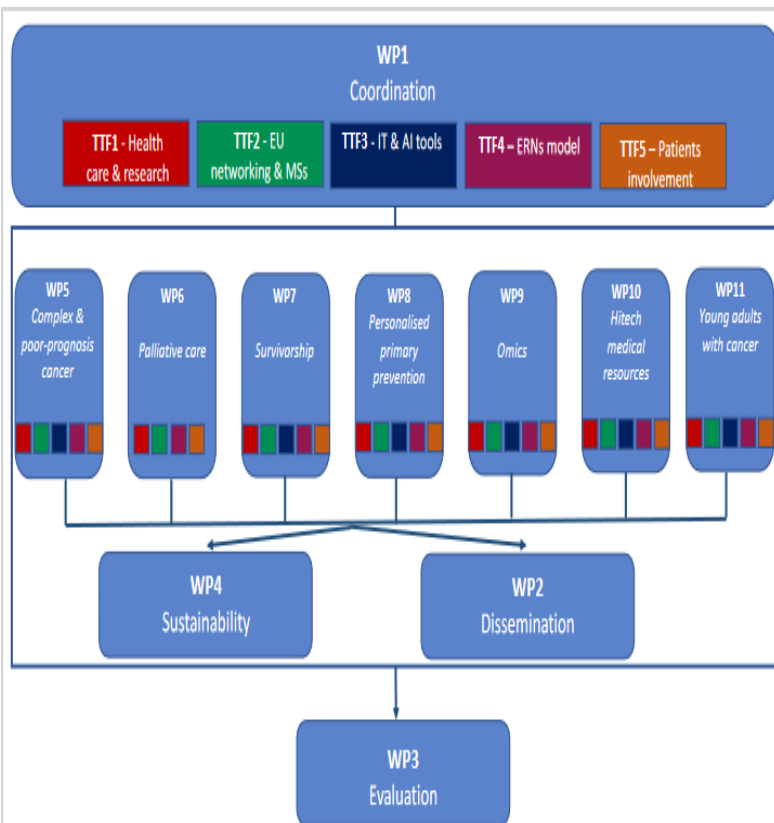
Main Activities

➤ JANE is paving the way to create 7 European NoEs for cancer care-related issues requiring European expertise, on:

- complex & poor prognosis cancer(s),
- palliative care,
- survivorship,
- personalised primary prevention,
- omic technologies,
- hi-tech medical resources,
- adolescents & young adults with cancer

➤ Five transversal task forces focus on issues linked to healthcare networking in cancer domain in the EU today, namely:

- integration between healthcare & research
- integration between EU networking & MS
- integration between IT infrastructure & AI tools
- the ERN model
- patient involvement in EU health networking



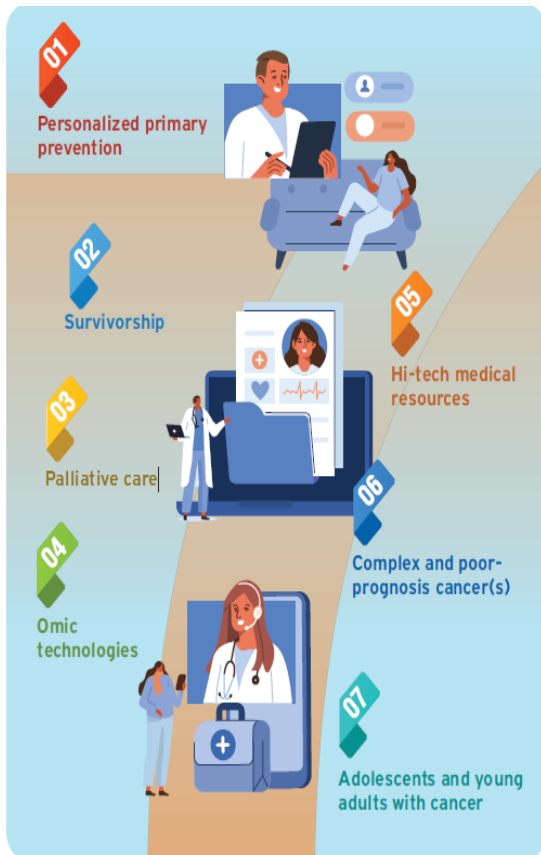
Expected Results and Benefits to the Patients and Society

By fostering coordinated relationships within European oncology community, JANE aims to find solutions that allow patients across EU to benefit from increased knowledge and expertise and more accessible health services.

Ambition of JANE is to shape effective new NoEs, building on previous and ongoing EU networking experiences, and finding solutions rooted in European oncology community.

Joint Action outputs will be shared with European oncology community and Member States, through a Green Paper and a European conference.

Healthcare networking could become a privileged hallmark of EU, having the potential to target the health of its citizens in a highly coordinated fashion.
